Other: The Family Place served as the fiscal sponsor for TC STRONG through October 2024, after which fiscal sponsorship transitioned to a new fiscal sponsor (Sustainable Health For All). Due to funder restrictions, remaining grant funds could not be transferred directly to the new fiscal sponsor and were instead disbursed through reimbursement of allowable expenses incurred on behalf of TC STRONG. During fiscal year 2025, a total of \$33,157 was transferred to the new fiscal sponsor through this reimbursement process, as seen in Schedule I, Part II above.

Other: In FY25, The Family Place served as a hub distributing supplies in the aftermath of Hurricane Helene. Items received and distributed included baby supplies, household items, medical assistance items, food, clothing, and children's toys.
